November 2023 Town Board Meeting Supervisor's Report

- 1. I reviewed the credit card monthly charges and found no issues.
- 2. 2024 TOWN OF DICKINSON BUDGET HIGHLIGHTS

Expenses:

- We completed a large project on Sunrise Drive in 2023 to replace sewer laterals, secure water pipes, pave and replace street curbs.
- The cost of health insurance was increased by 6%
- For 2024 there will be an overall 5% salary increase for appointed employees and elected officials, with pay adjustments made for the Town Supervisor, Highway Superintendent, Code Officer, and Water & Sewer Public Works Manager.
- We've seen the cost of materials increase over the past year, along with our Health Insurance.

Our Appropriations are up \$231,291 in 2024, however our Estimated Revenue is up \$924,689 in 2024.

Revenue:

- Small increase in property tax for the general fund at 1.29% which keeps us well within the 2% Tax Cap Limit.
- Sales tax budget is projected to increase by 5% in 2024
- We've streamlined our Water and Sewer billing costs to help keep the cost and expenses sustainable.

The bottom line is that the Town of Dickinson remains one of the lowest taxed towns in Broome County while continuing to offer many great services that our residents expect from their town. We will continue to seek out ways of saving money through shared services, more efficient operations and increasing our tax base through new developments, both residential and commercial. Our staff is to be congratulated for their hard work and dedication to the town and its residents. Our town board continues to do a great job in maintaining our town in an efficient and effective manner while keeping our spending as low as possible.

- 3. The walk bridge has been successfully removed.
- 4. Had a discussion with the owner of the EcoNo Lodge informing him that children staying at the hotel have caused damage to our fencing around the pump station and at several times have been seen climbing into the pump station. The sheriff has been notified. The owner stated that they will watch the children more closely and inform the hotel occupants of what has been taking place at the park.
- 5. I want to congratulate Councilwoman Exley on the nice article about her in the SUNY Broome Alumni Magazine.
- 6. We received our third quarter sales tax distribution check for the amount of \$306,991.35 which brings us to a total of 882,269.86. We estimated \$900,000 for 2023 so we are on target to meet or exceed that amount.
- 7. I participated in a ZOOM meeting with Congressman Molinaro on November 2.

O Commissioner Kie commented that Adams St is all completed. The water main is the worst in the town. It should be put on the schedule to be replaced. At least 1,000 feet of it. The services are steel not copper. Next year we will look to replace 3 of the services in that area. Being proactive has been good. The town has been hesitant to make reductions to water bills as we have had so many replacements.

CODE

- Ocode Officer Doyle explained that Chenango Fire Department was dispatched on Sunday morning to 929 Upper Front for a chimney fire. He went to the scene and a little bit later as the fire dept was locking up the details with the homeowner till it got serviced and repaired they found that the form that we currently have with code is outdated. A new draft of that form was created, and Attorney Coughlin has reviewed it and will be issued to the homeowner.
- o Code officer Doyle will be attending a county training class on Nov. 14th.
- The Broome County Health Department reached out and he will be working with them on doing inspections for the 3 hotels in our town.
- St. Stan school's engineer contacted Code Officer Doyle to tell him they have hired an
 engineer, and they will be moving forward with a draft copy for us to review on their
 improvements as they are trying to stabilize it.

ZONING

Nothing to report.

DISCUSSION:

- Councilperson Exley questioned about the BOCES expansion where the property was that they would be taking. Code Officer Doyle answered that it would be the stone house.
- Supervisor Marinaccio has not received any updates with what may have been going on
 with the Broome Developmental Center. Last month he had reported that some officials
 were coming in to look at some things and a lot of rumors and guessing as to why
 officials from Albany would be going there. One thing that happens every year is the
 state goes out looking for sheltering places for people that need sheltering on a
 temporary basis. The building is quite full.
- Commissioner Kie explained that on Glenwood Rd. there is a section that should have "No Parking" signs. Where it starts to split into 2 lanes there is a resident that

continuously parks their vehicle right at that place and it has gotten hit and yet they continue to park there. We do not have any jurisdiction with that, but we could pass to have "No Parking" and provide the county the signs, but they would have to put up the signs. A public hearing would be involved and will be looking to do that in the near future.

 Councilperson Gardner explained that Linda Jackson has not had the time to work on the Association of Towns and Villages for Broome County. He received a call that her assistant in training will be taking it over. They are looking to do a Christmas themed meeting on Thursday, December 7th.

The meeting was adjourned on motion of Councilperson Morabito and seconded by Councilperson Burns at 6:51 PM.
