A resident questioned the process of obtaining a food truck permit. If a food truck wants to set up on Broome County property, then they will need to have a permit from Broome County and the health department. The towns permit process is not to generate revenue. It is to make sure they have gotten their proper approvals from the health department. It will also depend on whether the food truck is there for charity. The county and health department will give them a yearly permit.
