SUPERVISOR'S MONTHLY REPORT October 2022

The Broome County Festival of Lights today announced the acquisition of the Tall Pines Players Club Forest of Lights, along with big plans for the 2022 Festival of Lights, including out-of-vehicle activities, expanding the event from a drive-thru lights show to an entire holiday experience, for the whole family to enjoy.

The Broome County Festival of Lights, now in its third year, has acquired the inventory of holiday lights and displays from the **Tall Pines Players Club Forest of Lights** – bringing one of the biggest holiday lights shows in Pennsylvania to Otsiningo Park, now serving Pennsylvania and Upstate New York.

The Broome County Festival of Lights is also expanding to include out-of-vehicle experiences, including visits and photos with Santa Claus and food and beverage vendors. And the classic holiday fireworks display will be back to light up the skies over Broome County for three nights.

SUPERVISOR'S REPORT CONTINUED:

- 1. **Town of Dickinson Fiscal Stress Report** from the **NYS Comptroller's office** indicates a level of ten total points which gives us a No-Designation score. That means that our town is doing extremely well in all categories of budgeting, spending, loans, etc.
- 2. **NYS Sales Tax** revenues continue to rise. The latest figures show around a 12% increase from last year. The sales tax that we receive helps us to fund our highway department activities and our general fund.
- 3. The **NYS Department of Transportation** will be installing a solar powered emergency cell phone station at the all-purpose trail that is on the new Front Street bridge. We have not received agreements for this device, but Joel and I did talk to a **DOT** representative. It also looks like once the bridge project comes to a conclusion, we will then be responsible for maintaining the trail as well as the new wooden fencing that is being installed at both ends of the bridge. This is an issue that will be discussed with the department. I am looking at this as another unfunded mandate by the state just like highway lighting is a mandate.
- 4. I am working with Steve as the **AOTV Treasurer** and Linda Jackson as **AOTV President**, in the final stages of development of scholarship funding for **SUNY Broome** students studying political science and criminal justice courses. This will be a \$500 scholarship awarded every year with a 5-year commitment by the **AOTV**.

RESOLUTION: SCHEDULING A PUBLIC HEARING AMENDING CHAPTER 528 OF THE TOWN CODE ENTITLED "VEHICLES AND TRAFFIC" TO PROHIBIT PARKING NEAR FIRE HYDRANTS ON NOVEMBER 7, 2022 AT 5:35 PM.

Attorney VanWhy reported that he has had contact from Mr. Maciak's attorney regarding the property next door to the Highway Garage and a contract has been worked out. We will add a discussion to the November work session, and a vote for approval at the November Town Board meeting, and then arrange for closing on the property.

Mr. VanWhy initiated a discussion of seeking penalties for code violations. Currently, after receiving several notices of violations and an appearance ticket, many of the code offenders will appear in court stating that they have corrected the problem and are now in compliance.

Attorney VanWhy stated that the Town typically has sought compliance, not penalties, and we withdraw after compliance. A harsher, more aggressive stance would be to seek a penalty. We would say to the violator: thank you for complying, but you did not comply on time. It is a policy decision.

Mr. VanWhy posed the question - do we push it off and let the violators go scott free or do we put more teeth in it? We may have to end up going to a trial which results in more time involved. Mr. VanWhy is more than willing to seek penalties if we want to be more aggressive. Supervisor Marinaccio stated it is very frustrating in that he receives a lot of phone calls from neighbors regarding code violations. It was noted that fifty percent are repeat offenders. Mr. Kie stated that the repeat offenders are smart, and they tend to comply just before they come in to court.

Attorney VanWhy would like to know internally, when we are in court, if they are first time offenders or repeat offenders.

Something to consider would be to impose a minimum fine for the first offense and impose penalties on repeat offenders.

- Kyle Doyle reported that 40 Sunset Drive has been torn down after having had a fire. The Assessor will be notified.
- 156 Bigelow Street is vacant, and the water is off.

Councilman Burns asked about the status of the 36 Pulaski property. Attorney VanWhy responded that the property owner Mr. B will be served appropriately once he is located. We are expecting a court date in early November.

Mr. Rafferty replied to Councilman Morabito's question regarding the zoning of the solar farm stating that it is R-1 with the issuance of the Special Permit from the Planning Board. Councilperson Morabito is very concerned about the environmental aspect of the solar farm that they will be destroying 18 acres of trees that will never be replaced. Mr. Kie commented that there is an environmental tradeoff. Mr. VanWhy noted that the Chairman of the Planning Board Jerry Ford is very thorough, and he is sure that Mr. Ford is asking a lot of questions regarding the effects of the project such as soil degradation, animals living there, and potential runoff. Mr. VanWhy stated there are many things to consider. Effectively, if the Town has concerns about the extent of this then our solar zoning law allows the town to hire an expert and we can charge the cost back to the developer because this is a significant clearing of land, and we would like an engineer to weigh in whether this is appropriate or environmentally justified. Mr. Rafferty stated that the developer has \$7500 in an escrow account.

The meeting was adjourned on motion of Councilperson Gardner and seconded by Councilperson Burns at 6:48 PM.
